Course Description and Objectives

Basic Overview of Superfund Online, a computer-based training course, provides an overview of the purpose, legal framework, and implementation of the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA). Throughout this interactive and easy-to-follow course, participants explore the activities performed under the Superfund program.

By taking the course, participants achieve the following objectives:

- <u>Understand the evolution of the</u> <u>Superfund program.</u> The course explores the origin, accomplishments, and future of the Superfund program.
- <u>Understand the statutory and regula-</u> tory basis for the authorities of OSCs and RPMs. The course provides an

overview of the roles of the OSC and RPM as they are defined in laws, regulations, policy, and guidance, including a comparison of authorities and liabilities.

 Learn about the three types of response activities defined under <u>CERCLA</u>. The course discusses the components of the removal, remedial, and enforcement programs and the major responsibilities of OSCs and RPMs in their work on Superfund responses, site cleanups, and enforcement activities.



Target Audience and Registration Information


The Basic Overview of Superfund Online course is intended to be an introductorylevel training course that provides an overview of the Superfund process. There are no tuition costs and the course is open to any Federal, state, and other stakeholders hoping to gain a better understanding of the Superfund process. Superfund support staff, such as administrative staff, contracting officers, community involvement coordinators, enforcement personnel, and environmental professionals new to the Superfund program also will benefit from the on-line training. Newly hired U.S. Environmental Protection Agency (EPA) on-scene coordinators (OSC) and remedial project managers (RPM) still are required to take the 3-day classroom

Fundamentals of Superfund to meet the inspector training requirements set forth under EPA Order 3500.1.

Enforcement Process Overview Course: Provides an overview of the EPA Superfund enforcement process for OSCs and RPMs. This training is an Executive Order 3500.1 requirement for OSCs, RPMs, and their first line supervisors.



About the CERCLA Education Center

The CERCLA Education Center (CEC) is a unique training forum implemented by EPA's Office of Solid Waste and Emergency Response. CEC courses have been developed cooperatively by the Office of Superfund Remediation and Technology Innovation; the Office of Emergency Management; the Office of Acquisition Management; the Office of Enforcement and Compliance Assurance; and the Office of Research and Development. Site managers from EPA regions provide technical advice, comment, and support. The CEC's structured curriculum, designed primarily for EPA hazardous waste site managers and responders, enables participants to attend training that is of particular interest to them and most appropriate for their projects and workloads.

The Community Involvement University (CIU) provides opportunities for headquarters and regional staff from EPA's programs to build skills needed for successful community involvement. ERTP As part of EPA's comprehensive program for protecting the public and environment from hazardous materials, EPA's Environmental Response Training Program's (ERTP) courses are designed for personnel who respond to spill events and investigate and clean up abandoned hazardous waste sites. Training is provided in health and safety and various technical operations needed to identify, evaluate, and control hazardous substances that have been released. ERTP also can quickly develop technically focused courses to address current issues facing responders (such as, Anthrax, biohazards, and air monitoring for Weapons of Mass Destruction).
