Boston's Logan International Airport is approximately 2.5 miles (15-20 minutes) from the area around the EPA Region 1 offices. The airport offers the services of the following rental car companies: Alamo, Avis, Budget, Dollar, Enterprise, Hertz, National and Thrifty rental car. Taxis are located outside the terminal and run from \$20 to \$25 depending on traffic.

If you choose to use Mass Transit for transportation from the airport to an area hotel, it will cost you \$1.60. Just buy a Charlie Card and load it with any amount (but at least \$1.60). Take the free Massport Bus (either 22, 33, or 55) from the terminal to the subway airport station (Blue Line). Take the Blue Line Inbound (\$1.60 if you buy the Charlie Card). Disembark at the following stop



depending upon the hotel (we advise confirming all directions with the hotel where you plan to stay):

<u>Omni Parker House</u> or <u>Nine Zero</u>: Government Center Station, facing the curved building with your back toward City Hall, walk to the left on Cambridge St. (turns into Tremont)

<u>Holiday Inn</u>: Government Center Station, facing the curved building with your back toward City Hall, walk to the right on Cambridge St.

<u>Bullfinch Hotel</u>: or <u>Onyx Hotel</u>: transfer at State St. station from Blue Line to Orange Line. Take the Orange Line to North Station
