Pennsylvania which is located within walking distance (approximately a 5 minute walk) to the EPA Region 3 office. Local participants can park in the surrounding parking garages if necessary. Parking rates vary per garage.

# **Sleeping Room Reservations**

A block of rooms has been reserved at the Embassy Suites by Hilton Philadelphia Center City hotel in Philadelphia, Pennsylvania. Reservations need to be made before **Tuesday**, **August 8**, **2017**, to receive the government rate.

Included in the room rate is complimentary breakfast and evening receptions.

You are responsible for cancelling your hotel reservation if you cannot attend. The Embassy Suites hotel requires a notice of cancellation 72 hours prior to the day of your scheduled arrival. If you fail to provide notice, one night's lodging and tax will be charged to your credit card.

Hotel check-in begins after 4:00 p.m. and check-out time is at 11:00 a.m.

#### What to Pack for the Philadelphia Area

September temperatures range from 60°F at night to 80°F during the day. Please be advised that the temperatures in the meeting room do not reflect temperatures outside. Be sure to pack a jacket or sweater to wear while you attend the meeting. You are advised to also check the local forecast a few days before arriving.

#### Health, Fitness and Recreation

The Embassy Suites hotel offers several amenities, including a 24-hour complimentary fitness center which features a variety of cardiovascular and strength-training equipment.

#### **Dining**

There are many restaurants near the Embassy Suites by Hilton Philadelphia Center City hotel offering a variety of options including London Grill, TGI Fridays and Rose Tattoo. Many other dining options are available within walking distance of the EPA Region 3 office and the Embassy Suites hotel.

#### **Travel Information**

The Philadelphia area is served by the Philadelphia International Airport (PHL). PHL is located approximately 10 miles from the Embassy Suites hotel. Additional information for PHL is available at <a href="https://www.phl.org">www.phl.org</a>. For participants coming from Boston, NY, or DC, Amtrak is probably the easiest form of transportation. Philly's main station (30th Street Station) is about 1.5 miles from the hotel.

Philadelphia, Pennsylvania is located in the Eastern Time Zone.

### **Ground Transportation**

The **SEPTA Regional Rail "R-1train"** runs from the airport to center city Philadelphia. Take any R-1 train and get off at the Suburban Station stop (16<sup>th</sup> and JFK Boulevard). Fare is about \$5 which you can pay on the train. Exit the train and go up to the concourse level. Walk through the concourse to exit onto 16<sup>th</sup> Street. Head northeast on 16<sup>th</sup> Street toward Arch Street and turn left onto Benjamin Franklin Parkway. The Embassy Suites will be on your left after passing Cherry Street.

**From Philadelphia Amtrak 30<sup>th</sup> Street Station:** Philadelphia's historic train station is located about 1 mile (20 minutes walking) from the Embassy Suites hotel. Taxi fare to and from the hotel and the 30<sup>th</sup> Street Station is approximately \$10. Walking directions:

- Head east on Market Street toward Schuylkill Avenue.
- Turn left onto North 18th Street.
- Turn right onto Cherry Street and the Embassy Suites will be on your left after you cross Cherry Street.

Taxi fare between PHL and the hotel is approximately \$30 each way, not including gratuity.

Valet parking is available for \$53 per day with in and out privileges.

# Walking Directions to EPA Region 3 from the Embassy Suites Hotel Approximately 0.2 miles, 5 minutes

- Head east on Cherry Street toward Benjamin Franklin Parkway
- Turn right onto Benjamin Franklin Parkway
- Turn right onto North 17th Street
- The EPA entrance will be on the left-hand side of 17<sup>th</sup> street, just past Arch Street (the EPA building is green-colored glass with a white metal structure).
