What to Pack for the Lenexa Area

Average temperatures in June in Lenexa range from 64°F at night to 84°F during the day. Please be advised that the temperatures in the training room do not reflect temperatures outside. Be sure to pack a jacket or sweater to wear while you attend the training.

Taxi: Taxi fare between MCI and the hotel is approximately \$90 each way, not including gratuity.

Driving Directions to the Courtyard Kansas City Olathe from MCI Airport (Approximately 35 miles)

- ❖ From the airport, get on I-29 S/US-71 S in May Township from NW 120th Street.
 - ❖ Follow I-29 S/US-71 S, I-635 S and I-35 S to W 119th Street in Olathe. Take exit 220 from I-35 S.
 - ❖ Continue on W 119th Street to South Strang Line Road. Turn right.
 - ❖ Turn left on South Strang Line Court. The hotel will be on your left.

Driving Directions from the Courtyard Kansas City Olathe to the EPA Region 7 Office

(Approximately 2.2 miles, 7 minutes)

- ❖ Take S Strang Line Ct to S Strang Line Rd. Turn right on S Strang Line Rd.
- ❖ Take S Strang Line Rd to W 119th Street. Turn left on W 119th Street.
- ❖ Take W 119th Street to Renner Blvd (go across the highway). Turn right on Renner Blvd.
- ❖ Follow Renner Blvd past W 113 Street. The EPA Region 7 Office will be on your right.
