## Ground Transportation

**Taxi:** Taxi fare between MCI and the hotel is approximately \$90 each way, not including gratuity.

**Shared Ride Service:** Shared ride services such as Uber and Lyft are available from MCI to the hotel. Fare ranges from \$60 to \$70 one way, depending on the time of day and not including gratuity. For pick-up, follow the signs to the Arrivals commercial curb and look for the purple signposts 2K-N.

## Driving Directions to the Residence Inn Kansas City Olathe from MCI Airport (Approximately 35 miles)

- ❖ From the airport, get on I-29 S/US-71 S in May Township from NW 120<sup>th</sup> Street.
  - ❖ Follow I-29 S/US-71 S, I-635 S and I-35 S to W 119<sup>th</sup> Street in Olathe. Take exit 220 from I-35 S.
  - ❖ Continue on W 119<sup>th</sup> Street to South Strang Line Road. Follow for approximately 1.1 miles to the hotel.

## Driving Directions from the Residence Inn Kansas City Olathe to the EPA Region 7 Office

(Approximately 2.5 miles, 7-minute drive)

- ❖ Leave the hotel area and turn right on S Strang Line Rd.
- ❖ Take S Strang Line Rd to W 119<sup>th</sup> Street. Turn left on W 119<sup>th</sup> Street.
- ❖ Take W 119<sup>th</sup> Street to Renner Blvd (go across the highway). Turn right on Renner Blvd.
- ❖ Follow Renner Blvd past W 113 Street. The EPA Region 7 Office will be on your right.
