## Driving Directions to the Courtyard Kansas City Olathe from MCI Airport (Approximately 35 miles)

- ❖ From the airport, get on I-29 S/US-71 S in May Township from Cookingham Dr and N@ 120<sup>th</sup> St.
  - ❖ Follow I-29 S/US-71 S, I-635 S and I-35 S to W 119<sup>th</sup> Street in Olathe. Take exit 220 from I-35 S.
  - ❖ Continue on W 119<sup>th</sup> Street. Take S Strang Line Rd to S Strang Line Ct. The destination will be on the left.

## Driving Directions from the Courtyard Kansas City Olathe to the EPA Region 7 Office

(Approximately 2.1 miles, 10-minute drive)

- ❖ Leave the hotel area and head north towards S Strang Line Ct.
- ❖ Continue onto S Strang Line Ct. Turn right on S Strang Line Rd
- ❖ Turn left onto W 119<sup>th</sup> St. Turn right on Renner Blvd, followed by another right turn at the EPA region 7 office. The destination will be on the left.
